- 3. Move to a paperless office wherever feasible and reduce the usage of paper.
- 4. Favour where possible suppliers who remove packaging as part of their contract.
- 5. Favour suppliers who actively operate according to sound environmental practices.
- 6. Develop & maintain our company waste management plan report in order to accommodate effective waste management and minimise pollution. Share the outputs with staff to drive greater compliance to our environmental expectations
- 7. Ensure that all waste handlers who act on our behalf do so in accordance with good practices and regulatory requirements. We will conduct duty of care checks as required by law on our appointed waste carriers
- 8. Implement environmental management in conjunction with guidance given in the Dyno HSE Framework document
 - Encourage the procurement of recycled materials and those which are suitable for disposal by recycling.
- 9. Provide well maintained waste disposal facilities at our office premises, secured against trespass and the escape of waste materials
- Have robust spill response processes to deal with any accidental release of material that could impact ground conditions, water courses, etc. All environmental incidents to be reported via MyHse on 03332029615
